Bass Tournament Rules – 2017

Entry fee(s) due to David V. Van Scyoc by August 28, 2017 – Be sure to enter your phone number and/or e-mail address on the attached form(s) in order to receive confirmation of payment.

One person per boat shall be affiliated with a Mercer Lake Association Member. If a participant is not 18 years of age you must have written permission from a parent or guardian and be accompanied by an adult. Wisconsin residents who are 16 years old or older need a fishing license to fish in any waters of the state.

Boats maximum. The first 13 registration fees received will be accepted with subsequent entries placed on a stand-by list in the order received.

In the event a team cancels, the next team according to the stand-by list will be contacted to compete. NO REFUNDS will be given unless your spot can be filled from the stand-by list.

This event will be held rain, sleet or snow—severe weather before the start such as lightning will delay or terminate the event. If the tournament is canceled, all entry fees will be refunded.

Start time 7:00 a.m. Meet at the Mercer Lake Boat Launch for a briefing. Tournament end at 2:00 p.m.

Two rods per person.

Wisconsin Fishing Rules and Regulations apply. A legal Largemouth Bass is 14 inches.

This is a catch and release event (photos may be taken).

Fish must be netted (record time), length measured and released. Measure fish from tip of nose to end of tail. A coin toss will determine a winner in the event of a tie. Record length and time on the card provided.

Each boat must have a tape measure and watch/time-piece to record time.

The honor system applies when recording the length of fish and time caught. Please use sportsman-like conduct at all times.

Please return score card at 2 p.m. Saturday to the official at the Mercer Lake Boat Launch.

In the event no Largemouth Bass are caught, MLA would receive 100% of the entry fees collected.

Winner will be announced and prizes awarded at the Mercer Lake Association Potluck Dinner held the evening of September 2, 2017.

Any infraction to the above rules will result in disqualification.

Dear Fishermen,

This year Mercer Lake Association (MLA) will be sponsoring the Bass Tournament, to be held on September 2, 2017 from 7:00 a.m. until 2:00 p.m.

The following will apply to this years tournament:

- 1) 50% of the entry fees for the Bass tournament will be paid out to the first place winner of the Bass Tournament.
- 2) 50% of all entry fees collected will be allotted to MLA and will be used for future fish stocking.
- 3) First place winner of the Largemouth Bass Tournament will also receive a plaque.
- 4) In the event no Largemouth Bass is caught, MLA would get 100% of the entry fees collected and will be used for future fish stocking.
- 5) This years tournament will start at 7:00 a.m. and end at 2:00 p.m.
- 6) A maximum of 13 boats for the tournament.

Here are some examples of entry fee(s):

- 1 boat, 1-2 fisherman entering the Bass Tournament, entry fee would be \$50.00, add \$25.00 for each additional fishermen. Any person, regardless of age, actively fishing is consider a fisherman and subject to the additional charge if there are already two active fishermen in the boat.
